



The MSSP is a program administered by the Centers for Medicare and Medicaid Services (CMS) and CMS must approve all ACO applications. Part of the application process requires that an organization seeking ACO status must first organize itself as a separate legal entity. On December 11, 2012, SLCCC received official approval from CMS and began operating as an ACO on January 1, 2013. The approved operation period for the ACO is three (3) years. If SLCCC meets the thresholds set by CMS to qualify for reimbursement, then from CMS will reimburse SLCCC in the following manner:
